

## **COMMENTARY**


The fund returned positive 2.21% for the month of December 2022. Net exposure averaged 29% long, while gross averaged 141%. This brings our calendar year return to positive 1.75% and since inception return to positive 22.18% p.a. net of fees.

Over December, global equity markets (measured by the MSCI Index) bucked the typical trend of delivering a 'Santa Claus' rally but instead declined by 4.34% over the month. This takes the total year end decline for global equity markets to negative 19.5%, which in our view is the first leg of this bear market, multiple compression. We believe 2023 will be the year we see the beginning of the earnings downgrade cycle, as the headwinds of rising rates, pull forward of demand and rising costs of living begin to bite developed market consumers. With this view we will continue to run low net market exposure and position the portfolio for a slowing global economy through 2023.

We have kept our comments brief as we will be releasing our annual investor letter with a much more extensive update on our thoughts for the year ahead.







We strive to achieve asymmetric returns though a thematic investment process. This has four pillars.

- 1. Find asymmetric themes;
- 2. Invest in the best ideas within those themes;
- 3. Focus on macro drivers for risk & opportunities; and
- 4. Generate an asymmetric return profile.
